Overview

\$1,569,896 Commercial Mortgage Loan Sale (the "Loan Sale") conducted by Mission Capital Advisors, LLC ("Mission" or "Loan Sale Advisor") on behalf of an Unidentified Seller ("Seller").

Sale Structure

Mission has been retained as the exclusive Loan Sale Advisor to the Seller for the sale of a loan secured by a first-lien mortgage on retail property located in Brooklyn, NY (the "Loan" or "Asset"). The Loan is being offered on a sealed bid basis.

On behalf of the Seller, Mission is initially soliciting indicative bids from prospective bidders (the "Prospective Bidders") for the purchase of the Loan pursuant to the Loan Sale timeline attached hereto (page 3).

Mission, in conjunction with the Seller, and at the sole and absolute discretion of the Seller, will then invite multiple bidders (the "Final Bidders") to complete due diligence and submit non-contingent final bids for the Loan.

The sale must be completed according to the timeline attached hereto; investors will be required to finalize the Loan Sale Agreement prior to the final bid date.

Highlights & Loan Summary

The Loan Sale offers Prospective Bidders an opportunity to acquire a loan secured by a first-lien mortgage on a retail property located in Brooklyn, NY.

- Collateral is a one-story (plus basement) 12,792 sf retail building currently demised as two retail units. The 10,000 sf unit is leased to an established, regional grocer on a long term lease. The remaining 2,792 sf unit is vacant.
- The property's grocery tenant has reported stable sales of approximately \$5.7mm in both 2014 and 2015, resulting in an occupancy cost of approximately 3.0%.
- The property is located in the densely populated Cypress Hill section of Brooklyn with convenient access to the J and A/C subway lines.
- The loan features an attractive 6.53% interest rate.
- Based on the most recent appraisal, the LTV is approximately 52%.

Included in the Due Diligence Materials will be an Offering Memorandum for the Asset (the "Offering Memorandum") prepared by Mission, comprehensive bidding instructions, the terms of sale and the Seller's required form of Agreement for Sale and Purchase of the Loan (the "Loan Sale Agreement").

Mission is soliciting non-contingent final bids for the Loan. Prospective Bidders are encouraged to complete final due diligence before submitting non-contingent offers on the Final Bid Date (the acceptance of which by Seller will require immediate execution of prenegotiated Loan Sale Agreement by Prospective Bidder accompanied by a 10% non-refundable wire funds deposit). No obligation to sell shall be binding on seller unless and until a written contract of sale or loan sale agreement is signed and delivered by seller. Additional information will be provided to Bidders via Mission's online due diligence site. Such information may include detailed loan documents, pay histories, environmental reports, litigation documents (if applicable), and financial statements, in both computer file and imaged formats.
