Laurel Island REO and Judgment Sale (the "Asset Sale") conducted by Mission Capital Advisors, L.L.C. ("Asset Sale Advisor") on behalf of an unidentified seller ("Seller"). ### Sale Structure

Mission Capital Advisors, L.L.C. has been retained as the exclusive Asset Sale Advisor to the Seller for the sale of Laurel Island land, 48.49 acres of undeveloped land located in Kingsland, Camden County, GA, and a Judgment in the original amount of \$49,474,139.

On behalf of the Seller, Mission Capital Advisors, L.L.C. is soliciting a call for offers from prospective buyers (the "Prospective Buyers") for the purchase of the Assets pursuant to the Asset Sale timeline attached hereto.

### **Asset Sale Agreement**

The Seller will make its required form of Asset Sale Agreement available for review. Pursuant to the Asset Sale Agreement, the Seller is selling its Assets subject only to those representations and warranties explicitly stated in the Asset Sale Agreement. No other representations or warranties, either expressed or implied, shall apply.

No obligation to sell shall be binding on Seller unless and until a written contract of sale or Asset Sale Agreement is signed and delivered by Seller.

### **Investment Highlights**

The Asset Sale offers Prospective Buyers the opportunity to acquire a 48.49 acre portion of Laurel Island, a partially platted but undeveloped residential and commercial land community zoned PD (Planned Development) located in Kingsland, Camden County, GA, along with the related Judgment. The Asset Sale offers the opportunity to acquire the fee simple interest in the real property, as well as the opportunity to pursue amounts owed under the Judgment.

- Laurel Island is situated on the scenic Georgia coastline and is conveniently situated between Jacksonville, FL and St. Simons Island, GA.
- Laurel Island features rare and highly desirable 6,500 feet of waterfront / marsh front property.
- The Property consists of (i) Phase I & II containing 55 platted lots and 70 unplatted lots respectively on a total of 31.64 acres, and (ii) Oxley Village containing 73 unplatted lots plus commercial acreage on 16.85 acres.
- Water and electricity are available at the Property.
- Stunning creek views are visible from almost every portion
  of the Property. The Property is located just east of the
  Laurel Island Plantation, a master planned development
  with extensive amenities. The subject Property is in the
  path of growth for Camden County.
- The site is accessed via Marsh Harbour Parkway which terminates on the western portion of the Property. Interstate-95 can be reached four miles to the west, and connects the Property to major population centers Jacksonville, FL to the south, and Brunswick, GA to the north. King's Bay Naval Submarine Base, a 16,000 acre installation and home to the U.S. Atlantic Fleet's ballistic missile submarine units, is located two miles east of the Property.
- The Judgment provides potential additional upside for a purchaser.

### **Asset Sale Process**


