This offering provides Prospective Bidders an opportunity to acquire a well-located community shopping center in the Columbus Core Based Statistical Area ("CBSA") in central Ohio.

Stabilized, Income-Producing Property

The Property was 92.92% occupied as of June 30, 2018 with 20 tenants. The existing tenant mix consists of a blend of national, regional, and local tenants, with Planet Fitness serving as the junior anchor tenant and Kroger Marketplace serving as the major shadow-anchor.

Diverse Tenant Mix

The diverse tenant mix includes two fast-food restaurants, a physical fitness center, restaurant, beauty salon, dance studios, medical offices, and various other retailers.

Strong Local Market

The Property is located in the Columbus Core Based Statistical Area ("CBSA") in central Ohio, which is the third largest metropolitan area in the state. The diverse economy of Columbus and its suburbs include Honda's manufacturing facility that includes the addition of the Acura MDX production facility; corporate headquarters for clothing companies such as Limited Brands, Abercrombie & Fitch, and Tween Brands; and Fortune 500 companies such as Cardinal Health, Nationwide, and Big Lots.
