Sale Highlights

This offering provides Prospective Bidders an opportunity to acquire a value-add distribution center located in DeKalb, IL.

Value-Add Opportunity

Constructed in 2006, the Property consists of one precast and steel industrial building that was built-to-suit for its former tenant, 3M, that is now vacant. The building features clear height of 34 feet, one drive-in grade level door, and 37 dock-high loading doors. There are 112 surface parking spaces (0.6/1,000 SF) for cars and 89 trailer parking spaces (0.4/1,000 SF).

Excellent Location and Visibility

The Property is located in the Central Kane/DuPage West Suburban Industrial Submarket and the Chicago-Naperville-Elgin, IL-IN-WI Metropolitan Statistical Area, the third most populous MSA in the U.S. The Property is in close proximity to Interstate-88, Interstate-39, and several U.S. Highways and fronts two streets with great visibility.

BUYER QUALIFICATION
